Introduction and Background

Baho International Hospital (BIH) is a limited liability company operating in the Nyarutarama area of Kigali, in Rwanda and was incorporated with Rwanda Development Board (RDB) in 2016, but started officially its operations in 2017.

The hospital provides health care to national, regional and international patients. It currently employs almost 105 staff whereby 72 staff are medical staff and 33 represent administrative staff. It also has the capacity of handling 120 outpatients per day and 56 Inpatients, it operates 24 hours a day per 7 days of the week.

During the last three years of journey (2017-2020), the hospital's shareholders managed to construct a health facility which is now on its final stage of completion. The whole project cost is at almost Ten Billion Rwandan Francs (Rwf 10,000,000,000), fully completed.

Introduction and Background (CONT')

BAHO INTERNATIONAL HOSPITAL Ltd is an IIDEA partner since December 2019. The hospital received a grant of USD 50 000 from GIZ-EAC to support the project of building up an online portal for easy access to information and interaction between different Health Services providers and patients on health problem in Rwanda and Tanzania.

The hospital received the first installment of 40% almost equivalent to USD 20 000 at the end of the year 2019. Project activities were planned to start with the beginning of the year 2020, but it was not the case, because the hospital was forced to terminate the lead consultant contract at the end of February 2020 due to his unavailability and non-compliance with the terms of the contract between him and the hospital.

The hospital signed a new agreement with a new lead expert in March 2020 and the lockdown of almost 2 months came in due to the pandemic of COVID-19, project consultants were working from their homes and resumed project activities at the office in May 2020.

The development of the online platform went smoothly from June 2020 till to date, but a problem of business partnership with Tanzanian health facilities became a serious problem due to the COVID-19 pandemic impact of not crossing Rwandan border to Tanzania and fellow Tanzanians refused collaboration using online platform like zoom meetings. They suggested to wait till the boarders opening between the two (2) countries in order to have face-to-face meetings.

Based on the above challenges, the project implementation delayed somehow, but it is now amazing because the development of the online portal is now completed successfully and the prospective partners will be added up in the system after the official launch that is scheduled in this March 2021 if COVID-19 does not persist, if not we will organize official launch online by inviting online the prospective beneficiaries. The project implementation progress is now at 95%.











Objectives of the Project

The specific objectives of the project were the following:

Objective 1: To develop and test an online portal for health issues posing, solving, feedback giving and appointments requesting by patients in Rwanda and Tanzania,

Objective 2: To provide tailor-made and demand-driven technical support and advisory services to all stakeholders involved in this online platform implementation,

Objective 3: Promote awareness and the visibility of the platform in order to reach at least 500,000 beneficiaries at the end of the project.

Did you collaborate with any other organizations?

The collaboration with local organizations has been taken place, but with a lot of challenges faced at the beginning of the project and due to the lockdowns and the persistence of COVID-19. Due to the closure of boarders, it was not easy at all to collaborate with the Tanzanian prospective partners.

The hospital established a way of collaboration online with local health facilities whereby Seven (7) health facilities including hospitals and clinics accepted to join Baho International Hospital Ltd on the online platform. Among them we have SMILE DENTAL CLINIC, SAINTE THERESE POLYCLINIC, NGORORERO HOSPITAL, TRUST CLINIC, PROOMNIBUS CLINIC, BELLAVITAE CLINIC and CENTRE MEDICAL BAHO POLYCLINIC and we agreed that once this pandemic reduces its negative impacts, meetings and events will be organized for active collaboration.

Due to the delay of project implementation and impact of COVID-19, The communication interventions have not been so much active, but we recently started communications interventions with prospective partners for awareness of the project.

It is still too early for Baho International Hospital Ltd to conduct and evaluate monitoring and evaluation interventions because the development of the platform has been recently completed in January 2021. The hospital has a plan to conduct M&E on quarterly basis.

- o GIZ_RWANDA should make follow up to confirm the project sustainability


